

I asked the female operator to exit the Honda and speak with me. Upon exiting the Honda, I again asked if she was in possession of any illegal contraband, weapons or needles. She was forthcoming and stated she was in possession of marijuana in her fanny pack, which she was wearing around her waist.

I took possession of the fanny pack and while searching the interior, I located a small plastic baggie containing a green leafy plant like substance "suspected marijuana" and New York operator's license # _____ for Nakaya Prince _____. The photograph on the license was in fact the female operator who had previously identified herself as _____. I asked Nakaya who _____ is and she stated that she is her sister. Later Nakaya stated she knows her sisters SSN.

A query of Nakaya's NY operators license via _____ showed it to be suspended.

Later at MPD HQ, a small amount of the suspected marijuana was placed into Duquenois-Levine Reagent test kit for marijuana/THC. After following the manufacturer's test procedures, the material tested indicated the presence of marijuana/THC. Upon weighing the suspected marijuana it yielded a total package weight of 3.18 grams.

Nakaya was charged with violation of C.G.S. 14-296aa(b) – Using an Electronic Handheld Device While Operating a Motor Vehicle, 14-215 – Operating A Motor Vehicle With A Suspended Operators License, 21a-279a(a)1 – Possession of Less Than ½ Ounce of Marijuana, 53a-167 – Interfering With An Officers Investigation and 53a-130 – Criminal Impersonation.




