REMARKS

On 7-29-2019 Det Peck and I conducted a motor vehicle stop on PA registration after confirming the registration was expired in 2017. The operator of the vehicle (later identified as Julian Shuman by his CT operator's license). Told Det Peck he did not have any identification on his person or in the vehicle. Shuman provided the last name " to Det Peck.

I was able to find his license in possession of the passenger. When I confronted Shuman with his driver's license information he said something to the effect of, 'I have a lot going on with my name right now'. Upon checking Shuman through dispatch

we learned he had an active arrest warrant through the Groton Police Department.

Shuman was searched prior to being seated in a police car and Det Peck discovered two Suboxone sublingual packets. Shuman claimed he had a prescription but a check of the CT prescription monitoring website showed he has not had a prescription for Suboxone in at least three years.

Shuman was issued MSC# MC 378550 for 14-12a* operating an unregistered motor vehicle, 21a-279(a)(1) possession of narcotics and 53a-167a interfering. Shuman was transported to the Middletown Police Department to be held for the Groton Police. Shuman has no

REMARKS

On 08/07/16 approximately 16:30 hour(s) this officer (Sgt Baboolal) was conducting specific/ directed motor vehicle enforcement as part of a distracted driving grant. I was in a marked police patrol cruiser traveling north on Main St and then turned left onto Washington St. traveling west.

At the intersection of Main St. and Washington St. I observed a small black vehicle, later identified as CT

, a 2007 Mazda (Mazda3) that was operated by the sole occupant Michael J. Malcolm, the accused.

I observed the vehicle accelerating as it made the corner and travel left into the left travel lane at a high rate of speed. I observed the vehicle pull to the left without signalling and cut off another vehicle. The vehicle approached the intersection of Washington St at High St, I accelerated and was able to get behind the vehicle. The vehicle almost rear ended the vehicle in front of it. Once the light changed from red to green I observed the vehicle pull right into the right travel lane without signalling and then travel at a high rate of speed to the intersection of Washington St at Newfield St. I observed the vehicle to travel to the right onto and over the right side fog line almost onto the curb and then travel back to the left and straddle between the two west bound lanes. The vehicle was forced to stop due to traffic and the vehicle almost struck the line of stopped vehicle.

Once the light changed from red to green the operator pulled to the right, cutting in front of traffic and again swerving from over and past the right fog line to the straddling the two west bound lanes. Traffic was heavy at the time due to it being the evening rush hour. The vehicle had to pull to the right at the last minute to avoid striking a marked police cruiser that was stopped just past Butternut St on the right side of Washington St west bound. As we approached the intersection of Bernie O'Rourke Dr. I activated my overhead lights and siren to stop the vehicle. The operator pulled into the business parking lot and stopped at 534 Washington St. I used the painted parking space lines to have the accused perform the field sobriety tests. The area was flat and free of debris. The weather was slightly cloudy and still daylight.

On approach I did observe the accused to have glossy eyes and he appeared to be under the influence. On interview I asked him if he had consumed any thing today and he said he did. I asked him what did he consume, and he said a couple of shots. I asked him where and he said down on Main St. I had him shut his vehicle off and step out. I explained that he was going to be field tested using the standardized field sobriety test. He said he understood and that he was having a bad day as he had gotten fired and it was his birthday.

The accused was arrested and handcuffed. The handcuffs were put on loose enough to place one finger between the cuff and his wrist and double locked. On view of the interior of the vehicle on the driver seat was an orange pill, with "R" and "029" stamped on it. I asked the accused what it was and he said it was xanax. At the police station, the pill was researched online at www.drugs.com/pill_identification.htm and the website listed it as Alprazolam 0.5mg. A search of the interior of the vehicle returned with finding six (6) empty nip bottles of Parrot Bay 90 Proof rum and three (3) unopened nip bottles of Parrot Bay 90 Proof rum. Ofc. Scoppetto transported the accused to police HQ for processing. The accused' s vehicle was towed by Alpha Auto, 170 North Main St Middletown, Ct 06457 (860) 885 4611. The accused was provided with a copy of the tow form.

The accused also explained that he had also smoked Marijuana, snorted Zanax, and taken an Oxycodone pill. He stated that when he was on Main St in Middletown his friend gave him five (5) Zanax pills. I only located one (1) in the vehicle.

The accused was asked to perform the breath test. Ofc. Scoppetto instructed the test, and tested the accused. The first test was administered at 17:31 hour(s) and returned with a result of 0.0926. The second test was administered at 17:52 hour(s) and returned with a result of 0.0802. The accused was given a copy of the results.


The accused was process and released on a \$5000 non surety bond. He was charged with Operation while under the influence of liquor or drug or while having an elevated blood alcohol content 14-227a, Illegal obtaining or supplying of drugs 21a-108, and Person receiving narcotic drug to keep it in original container

21a-257 cgs. He was given a court date of 08/21/19 09:30 hour(s) at 1 Court St Middletown, Ct 06457. He was released to _____ at 19:50 Hour(s).
