





\_\_\_\_\_ r stated that the vehicle was a black four door sedan and provided a CT license plate of 488WMF. \_\_\_\_\_ r described the operator as a while male with brown curly hair, about 5'9" with a medium build.

I observed a long dent / scrape along the left side of the bus with what appeared to be black transfer paint.


The registration came back to a black 2008 Buick Lucerne out of 83 Dix Ave. in New Britain. New Britain Police checked the address and located the vehicle in the driveway. I responded there and spoke with the operator who was identified by his CT Operator's license as Parente, Thomas P of 352 Newfield St.

Middletown. Parente admitted that he had been driving the vehicle at the time of the crash. Parente admitted striking the bus and getting out to speak with the bus driver. Parente stated he left because he didn't think it was a big deal.

The vehicle showed fresh damage to the front end and right front bumper consistent with the crash.

Parente was issued a Misdemeanor Summons (MC 378276) for Evading Responsibility, 14-224. Parente is scheduled to appear at Middletown Superior Court on 12/28/16.


## REMARKS
