REMARKS

On 12/03/16 at 7:45 p.m hours, Middletown Central Dispatch that they received two 9-1-1 calls regarding an erratic driver that's all over the road on So. Main St. near Crescent St., and that it was bearing Ct registration 584 ZMY.

I radioed dispatch that the vehicle, a blue Audi sedan, was at the intersection of Crescent St. and Main St. Extension. The vehicle was stopped for a red traffic signal. I pulled directly behind said vehicle and it continued south on Main St. Extension in response to a green light.

The vehicle drifted to the left side of the road and across the double yellow lines for about 200' traveling approximately 25 mph. I activated my over head emergency lights and siren attempting to make a motor vehicle stop due to the operator's erratic driving.

The vehicle continued and turned right onto the Rt. 17 connector. The operator stopped the vehicle at Rt. 17 and So. Main St. for a red traffic signal. I shine my spotlight inside the cabin of the vehicle to get the operator's attention. The operator then turned left onto So. Main St. heading south at about 25 mph when the light turned green. The vehicle continued to drift to the left across the double yellow lines of So. Main St. and onto on coming traffic.

The operator continued for about 3/4 of a mile drifting in and out of on coming traffic before it made a wide left turned striking the curb as she was attempting to pull into the parking lot of Illiano's restaurant on So. Main St. The operator parked her vehicle in the driveway of the restaurant.

I exited my cruiser and I approached the operator. I removed the operator out of her vehicle and handcuffed her. She was advised that she was being detained. I detected an odor of an alcoholic beverage emanating from her breath the moment I made contact with her.

The operator said that she didn't hear sirens nor did she see flashing lights. I asked Jacquelyn if she be willing to perform a field sobriety test, to which he agreed.

Jacquelyn failed the field sobriety test. She was transported to police lockup for processing.

The first breath test was administered at 20:34 hours and registered a blood alcohol count of 0.1350. The second breath test was administered at 20:55 hours at least ten minutes after the first test and registered a blood alcohol count of 0.1312.

Jacquelyn was charged with, driving under the influence of alcohol and/or drugs, 14-224a, failure to maintained lane, 14-230 and failure to obey officer signal, 14-223(a). Jacquelyn was released to her sister on a \$500 non surety bond. she was assigned a court date of 12/16/16 to appear at GA 9 at 09:00 hours.

REMARKS

On December 1, 2016 at approximately 0133 hours, a Middletown Police Officer heard a loud noise nearby, resembling a motor vehicle accident, and observed a small sedan rolling to a stop on Main Street. The vehicle appeared to have front end damage.

Contact was made with the operator of the sedan. Caitlin McAuliffe was identified by her CT driver's license.

Upon arrival, the accused, Caitlin McAuliffe, was observed sitting in the driver seat of the vehicle; CT-AC24697 (gray colored 2003 Honda Accord). McAuliffe was positively identified by her CT driver's license. McAuliffe stated that she was driving home from the bar, then was returning to the bar to check on some friends when she swerved right and struck the rear of an unoccupied, parked vehicle. McAuliffe stated that she was not injured.

While speaking with McAuliffe, an odor of an alcoholic beverage could be detected on her breath. When asked, McAuliffe stated she had one "Rum Runner" since 10pm. She stated she knew the English alphabet, but was unable to recite an asked portion of it correctly.

Based on the failure of the Standardized Field Sobriety Tests McAuliffe, was placed under arrest and transported to Headquarters.

At Headquarters, McAuliffe was read her rights, read the Implied Consent. McAuliffe, then agreed to take the breath test.


McAuliffe's first breath test was administered at 0241 hours and registered a blood alcohol content of .1562. McAuliffe's second breath test was administered at 0301 hours and registered a blood alcohol content of .1449.

McAuliffe was processed under the following charges: Driving Under the Influence, 14-227a and Possession of Drug Paraphernalia 21a-267(A). McAuliffe was released on a five hundred dollar non-surety bond at 0600 hours. McAuliffe is scheduled to appear in court on December 15, 2016 at 0900 hours.

When I called Central Dispatch with the marker plate on it, CT Reg 2AGWP8, they advised it belonged on a 2013 white Grand Cherokee.

I initiated a motor vehicle stop on Cross Street. Upon contact with the owner/operator Oswald Johnson (36) he admitted right away that he was misusing the marker plate and that vehicle was uninsured and unregistered.
