
had expired on 3-7-14.



## REMARKS

On 1/31/2017, at approximately 1227 hours, I was dispatched to Middlesex Hospital in room 701 for an unwanted person complaint.

The victim told me that she and is divorced from her ex-husband, Michael Marino. She said as a result of numerous domestic incidents there is an order of protection issued by GA9 that indicates, among other things, that Michael is to stay 100 yards away from the victim and that Michael is not to contact the protected party "or others whom the contact would be likely to cause annoyance or alarm to the protected person". She told me that she that Michael had violated the order.

The victim gave me a sworn written statement in which she said the following:

*On 2/31/2017, sometime around 12pm I was at the Middlesex Hospital Hospice floor in room 701. My father is dying and I am at the hospital to be with him. My family and I walked down to the family room to discuss some things. We then walked back to the room and I saw my ex-husband, Michael Marino, walk out of my father's room. Michael looked right at me and started walking towards me. He said something, but I could not understand him. I said to my brother, "He can't be near me". My brother walked towards Michael and said something to him. Michael and my brother were conversing back and forth and it appeared like Michael was not going to leave. Michael was approximately 10 feet away from me. I walked back to the family room. Someone called security. In about 3-4 minutes a nurse told me that Michael left.*

*Michael knows there is a protective order between us. He has violated it in the past. I do not know why he was here, but he caused me and my family great distress.*

It was clearly evident that not only were the family members upset about the loss of a relative, but they were also clearly upset that Michael had done what he did in their time of mourning.

I spoke to the registered nurse assigned to room 701. The RN indicated that she knew the family had left the room to talk in the family room. She said she went into room 701 and saw a man she did not know to be part of the family there. She asked who he was and he said he was Michael Marino and he was the victim's husband. He told her he was a pastor and was there to pray for Mr. Marino. She said that when the family saw Michael in the hallway, they were alarmed and upset by his presence.

I spoke to Michael and he told me that he had been at Middlesex Hospital around noon time to visit his ex-wife's father who was dying. He denied having any contact with her. He said he did not make any attempt to ensure that the victim was not the hospital when he was.

Given the fact that the nurse placed Michael at the hospital and had direct contact with the victim's father, causing her alarm and annoyance, coupled with the fact that he was within 10 feet of her, Michael Marino was placed under arrest.


Marino was placed in custody and brought to the booking room. He was fingerprinted, photographed and processed. He was advised of his rights and refused to make any further statements.

Marino was held on a \$5000 surety bond for violation of CGS 53a-223 Violation of a Protective Order. He is scheduled to appear at GA9 in Middletown on 2/1/2016.

Marino has a prior conviction for violation of a protective order.
