## REMARKS

On February 13th 2017 at approximately 1617 hours I (Ofc. Terrible) was dispatched to #416 E Main St, Stop and Shop for a Shoplifting complaint.

Upon arrival I met with the Asset Loss Prevention Store Detective, who explained to me that a Tammy Duostuo arrived at their business and stole several makeup items from the business. During the course of the theft Duostuo removed one (1) of the makeup item from its intended packaging and placed it among five (5) other makeup items inside of a Stop and Shop flyer and closed it to conceal them. Duostuo proceeded to the soda/water aisle and placed a multi-pack of water on top of the hidden items and proceeded to the checkout line. Upon checkout the items were never removed from the carriage and Duostuo exited the store. The items stolen were valued at \$78.64. Loss Prevention provided a Sworn Written Statement and informed me that Stop and Shop wishes to press charges against Duostuo. They provided a copy of surveillance video footage and receipt of the stolen items.

After speaking with Loss Prevention and watching the surveillance footage Duostuo was issued a Misdemeanor Summons #MC378488 and charged with C.G.S 53a-125(b); Larceny in the 6th. She is scheduled to appear at G.A #9 on February 27th 2017 at 0900 hours. Duostuo was released on a Promise to Appear, which she acknowledged by signing. She was then informed that she is no longer permitted to

be on the premises of Stop and Shop. Nothing further

**REMARKS**

On February 13th 2017 at approximately 2458 hrs Officers arrived at the Victims residence for a report of a physical domestic.

Upon arrival Officers observed the victim and the accused in a physical altercation. Officers separated the two of them.

The accused (who had no picture identification) was later identified as Jessenia Roman-Huertas via the victim, the witness, and hospital records.

The Victim stated that Roman-Huertas and she live together and are currently in a relationship. The Victim stated while discussing a past relationship with Roman-Huertas, Roman-Huertas began to punch, bite, and hit the victim. The Victim yelled several times to stop but Roman-Huertas would not get off. The Victim had

bite marks and abrasions on her face, hands, arms, and stomach.

A witness in the apartment confirmed that Roman-Huertas attacked the Victim and the Victim only fight back in self-defense.

Upon speaking with Roman-Huertas she refused to say anything besides "go ask the victim". Several more attempts were made to ask Roman-Huertas what happened however she became more defensive and uncooperative despite having her own injuries as well; which she refused to explain.

The Victim gave a sworn written statement.

Later Roman-Huertas was transported to Headquarters. There she was read her rights, processed and held on a ten thousand dollar surety bond for the charges of Assault 3rd (53a-61) and Disorderly Conduct (53a-182).

She is scheduled to appear in court on February 14th 2017 at 0900 hours.
