

REMARKS

On Friday 02-03-2017 at approximately 2050 hours I, Detective Lathrop was traveling S/B on Main Street in an unmarked MPD Police Vehicle. I was following a maroon Pontiac Grand Prix which did not have a rear marker plate displayed. I radioed MPD dispatch and told them I would be stopping the Grand Prix once I was past the intersection of Main Street and Washington Street.

I activated my emergency lights and siren and initiated a motor vehicle stop of the above vehicle in front of Amato's Toy Store (395 Main Street). I approached the vehicle and I observed a marker plate in the back window of the Pontiac Grand Prix which could not be seen from my vehicle. I identified the operator as Daeshawn J. Kelley from his CT operator's license. Kelley immediately admitted he didn't have a valid registration or any insurance on the Pontiac Grand Prix he was operating. I asked Kelley if he owned the vehicle and he stated he did but hadn't been driving it until today. Kelley stated he took his plates from his old vehicle, a Volkswagen Passat and put them in this vehicle because he could

not afford to pay to get the Pontiac insured or registered correctly due to lack of paying property taxes. I called in the marker plate, 9AFHD3 which was displayed on the Pontiac in the rear window and confirmed what Kelley told me. The marker plate did belong to Kelley and it was supposed to be on a 1999 Volkswagen Passat but the registration was expired. He also had the matching plate on the dash board in the front window of the Pontiac.

I issued Kelley Misdemeanor Summons #MC 378294 in violation of CGS 14-147 Misuse of a Marker Plate and 14-213b Insufficient Insurance. Kelley was given court date of 02-21-2017 at GA-09 which is located at 1 Court Street Middletown, CT 06457 at 09:00 hours.

Kelley's vehicle was parked in a parking stall and he would make arrangements to have the vehicle removed at a later time. I removed the marker plates from the Pontiac and they were turned into the DMV return bin at MPD headquarters.
