REMARKS

On the above date and time, Middletown Police Officers were exiting 386 Main Street when they noticed a brown late model mini van operated by a male creeping slowly south curbside. Although the van was moving, the left rear tire was not spinning and was skidding across the roadway as if the emergency brake was on.

Upon contact with the operator, identified via his CT Drivers License as Alexander Rivera (37) he was asked if everything was okay with his vehicle and he didn't answer, he just blinked. The second time the accused was asked if he was okay, or if he needed medical attention, he continued to blink slowly and still.

When the accused was asked to step out of the vehicle, he was unsteady on his feet and swayed from side to side. The accused could not answer any questions as to where he was or where he was heading. The accused was asked he had family to call and also if he needed medical attention, but did not answer. His eyes were dilated and due his slowed speech, delayed responses, he appear to be under the influence of some type of narcotic. Due to the fact that the accused was unsteady on his feet, it was decided it was unsafe to try and conduct any field sobriety tests. The accused was advised that he was being placed under arrest for driving under the influence of drugs/alcohol and he was handcuffed and placed in the back of my cruiser. At headquarters, the accused refused to submit to a urine test.

The accused was processed and released on a five hundred dollar non-surety. He was assigned and court date of 02/08/17, 0900 hours at GA9 where he will answer for the charges of operating a Motor Vehicle Under the Influence of Alcohol or Drugs, in violation of CGS 14-227a.

REMARKS

On 02/07/2017, at approximately 2150, Middletown Officers responded to an undisclosed address in Middletown for the report of an unwanted person. This was the second incident involving the accused this evening. During the first incident Antonio Rogers was in the victim's apartment and was unwanted. Rogers was searched and placed under arrest. Rogers was transported to Middletown Police Headquarters for processing. Rogers was read his Notice Of Right which he refused to sign at approximately 2305 hours. Rogers refused to be fingerprinted or his booking photograph taken.


Rogers property was inventoried at which time a smoked cigarette containing what appeared to be marijuana was discovered. The suspected marijuana was tested using a N.A.R.K (Narcotics Analysis Reagent Kit) Number 1009 which indicated a presence of T.H.C (Tetrahydrocannabinol).

Rogers was held on a 5000.00 dollar Surety Bond for the following charges: 53a-107; Criminal Trespass 1st Degree, 53a-182; Disorderly Conduct; 53a-183; Harrasment 2nd Degree Non Threatening, and 21a-279a(a)1; Possession of Less Than 0.5 Ounces Of Marijuana. Rogers was issued a next day court date of 02/08/2017 at 0900 hours at G.A #09 which is located on #01 Court Street Middletown, CT 06457. There are no orders on file.

REMARKS

On the above date and time, I, Officer Aura Smith and Officer Pellegrini were dispatched to Rite Aid at 10 Main Street for a reported shoplifter in custody.

Upon arrival we spoke with loss prevention manager [redacted] gave a sworn written supplement, summarized as follows - at approximately 1400 hours [redacted] : observed a black female enter the store and head to the pharmacy area where she dropped off a prescription.
