REMARKS

On 01/06/17 I was dispatched to the parking lot of Dunkin Donuts on South Main Street for a motor vehicle accident. The complainant told Central Dispatch that there was a truck that had gone down an embankment.

Upon arrival I observed an older red Ford F150 which had rolled down the embankment in the back corner of the lot. I spoke with the vehicle's owner, Craig Mayer, who stated that he was driving around the back of Dunkin Donuts to exit, but because of the snow, lost control of the vehicle. He further stated that he attempted to avoid the problem but oversteered and cause the vehicle to end up down the embankment. Mayer admitted that he struck a blue Nissan Altima located nearby, later found to be owned by Christopher Sansone, an employee of Dunkin Donuts. Mayer further admitted that his operator's license was suspended, the vehicle was unregistered and uninsured, and the plate currently on the truck was not intended for that vehicle.

Mayer was issued a misdemeanor summons for Operating a MV while Suspended (C.G.S. 14-215a), Operating an Unregistered MV (C.G.S. 14-12(a)), Insufficient Insurance (C.G.S. 14-213b), and Misuse of Plates (C.G.S. 14-147(C)). Mayer was given a court date of 1/20/17 for this case

REMARKS

On January 13, 2017, at approximately 1512 hours, I (Officer Stroud) observed a black male walking south on Pearl Street carrying an Amazon package. I believed that behavior to be suspicious, due to packages normally being delivered directly to one's doorstep, and not requiring one to walk with it down the street.

I observed that male walk behind a residence on Court Street, and reemerge on Pearl Street without the package.

Upon making contact with that male, he was positively identified by his Connecticut Identification Card as Terrance Harding.

A search of the rear of the previously mentioned Court Street residence, yielded an Amazon package that was addressed to a separate individual, and had been opened. When I returned to Harding with that package, he denied having taken the package. Harding would later state "can I just give those back to them", referring to the property in the Amazon package.

Harding was placed under arrest for the following violation of the Connecticut General Statutes:

53a-125b, LARCENY IN THE SIXTH DEGREE

Harding was issued Misdemeanor Summons And Complaint # MC 455173, and is scheduled to appear at G.A. 09 on January 27, 2017, at approximately 0900 hours.
