REMARKS

On 1-16-2017 Sgt Yepes was conducting surveillance in the area of Rapallo Ave and Main St. This is a high crime area known for narcotics offenses, prostitution, and other quality of life issues. He observed the vehicle bearing CT reg 9AXPM0 in the area. He advised us the operator left the vehicle and met with a male briefly. The operator (later identified as Daryl Daniels) met with the male for a short period of time before returning to his vehicle. This behavior is consistent with narcotic activity.

Detective Peck and I observed the vehicle bearing CT registration 9AXPM0 traveling south on DeKoven Dr with no front license plate in violation of CGS 14-18a. We conducted a motor vehicle stop on the vehicle on Union St. Upon approaching the vehicle I met with Daniels. Daniels appeared nervous, was speaking very

quickly and moving his hands around the vehicle. He admitted to his driver's license being suspended.


Daniels was also transported to the police department. He was charged with 14-18a no front plate and 14-215 operating a motor vehicle with a suspended license on UAR 8873908. He was given a court date of 01-30-2017 at GA-09 in Middletown and released on a \$500.00 non surety bond.

REMARKS

On 1/24/17, at approximately 10:02 hours, I, Officer Foss-Rugan along with Officer Bloom responded to the area of #21 Spring Street for a parking complaint. The Middletown Parking Authority reported that they had put a parking boot on a green colored Ford Taurus that had the plate CT 225 VAJ displayed in the rear window of the vehicle.

The owner of the vehicle, Anthony W. Leonetti was also on scene. Leonetti said that the vehicle has valid insurance but was not registered. Leonetti said that he had a plate from a friends van in his trunk and displayed it in the rear window of the vehicle because he had to park it on the Spring Street so the driveway could be plowed. Leonetti admitted that he put the plate in the rear window and then drove the vehicle onto Spring Street where he parked it.

The plate (225 VAJ) was removed from the vehicle and returned to the Department of Motor Vehicles. Leonetti was issued a Misdemeanor Summons MC379697 for 14-147 Misuse of mark plates. A court date of 1/8/17 at 09:00 hours at Middlesex Superior Court was issued.
