**REMARKS**

On 1/18/2017, at approximately 2124 hours I, Officer Foster, was traveling Northbound on East Street in a marked Middletown Police cruiser. Traveling in front of my vehicle was a grey Honda Civic bearing CT registration 6APRB7. A check with dispatch revealed that the vehicle's registration had expired as of


October, 2016. I activated my emergency lights and siren to initiate a motor vehicle stop for the violation. The vehicle traveled approximately 1,500 feet Northbound on East Street and turned right onto Berlin Road (Cromwell) without stopping. The vehicle then slowed its speed and pulled over to the right hand side of the road. I requested an Officer from Cromwell to respond due to my geographical location and Officer Sanford came as well. I approached the operator on the drivers side who identified himself as, ' Bryant appeared to be very nervous and was moving around in his seat looking for something. Bryant was avoiding eye contact and was giving short answers to simple questions.

Based on Bryant's unusual behavior, I asked him to step out of the vehicle to speak with me. Bryant stated he did not have any form of identification on his person but informed me his name was ". Bryant could not provide me his date of birth and spent abnormal amount of time thinking of it. Finally, Bryant confessed that his real name was Christopher Bryant and stated his ID was in his vehicle. Bryant also stated that he had a small amount of marijuana in the vehicle. A check with dispatch revealed that Bryant had a suspended operators license and was not to operate a motor vehicle. A subsequent search of the vehicle yielded three individual baggies of suspected marijuana located in the center console. The suspected marijuana was later weighed to 1.54 grams and was tested with NARK kit #8 which yielded positive presumptive results. A further search of the vehicle resulted in a glass smoking pipe with marijuana residue located under the drivers seat. All above contraband was seized as evidence and transported to Middletown Police HQ. A further search of the vehicle was negative in results.

Bryant was issued a Misdemeanor Summons for violation of C.G.S. 14-215 Operating a Motor Vehicle with a Suspended License, violation of C.G.S. 14-223 Disobeying the Signal of an Officer, violation of C.G.S. 14-12(a)\* Operating an Unregistered Motor Vehicle, and violation of C.G.S. 21a-279a(a)1 Possession of Less than 1/2oz of Marijuana. Bryant was given a court date of February 1, 2017 at 0900 hours. The vehicle was towed from the scene by Midtown Towing.
