
REMARKS

Upon arrival we met with Operator #1 and Operator #2, who both stated they were uninjured at this time.


While speaking with Operator #1, she explained to us that she was attempting a left turn off of St. John St and onto Hartford Ave. As we pointed to the visibly marked no left turn traffic sign on St. John St, Operator #1 was made aware of her mistake. The St. John St. and Hartford Ave intersection restricts any vehicles from exiting left from St. John St due to its limited visibility. Operator #1 also informed us that she does not have current registration, insurance, and marker plates for the vehicle, which was confirmed through the system by Dispatch. Operator #1 stated she used her registration plate from a previous vehicle to misrepresent the unregistered Vehicle #1.

Based on the investigation Operator #1 was issued a Misdemeanor Summons #MC455051 for C.G.S 14-12(a)*; Operating an Unregistered Motor Vehicle, C.G.S 14-147(c); Misuse of Registration Plate, C.G.S 14-215; Operating a Motor Vehicle while Registration Suspended, C.G.S 14-213a; Failure to have Insurance. She was issued a Verbal Warning for C.G.S 14-242; Restricted Turns. Operator #1 was released after her signature of acknowledgment on a Promise to Appear and is scheduled to appear at G.A #9 on January 30, 2017 at 0900 hours. Nothing further.

REMARKS

On January 27, 2017 at 0110 hours, I, a Middletown Police Officer was on routine patrol in a marked police cruiser. I was traveling southbound on High Street approaching the intersection with Washington Street.

At this time I observed a vehicle bearing CT. Reg. 156YJZJ stopped for the traffic signal at the above mentioned intersection. I made a DMV Inquiry through Central Dispatch regarding the registration. Dispatch advised me that the registration was expired as of 10/25/2015. Also that the registered owner; Adam Rightmer has an active Warrant. The vehicle was a 2004 Subaru Impreza, color gray.

I initiated a motor vehicle stop by enacting my emergency lights and siren in the area of High Street and William Street. The operator responded by pulling over onto the shoulder of the roadway. I then made contact with the operator and advised him of the reason for the motor vehicle stop. At this time he admitted that he is aware that his vehicle is unregistered and also that he does not have any insurance. I asked him to provide me with identification at which time he stated that he did not have any on him however he provided me with his name and date of birth; Adam Rightmer (37 YO).

Rightmer advised of the active warrant and was taken into custody.

Rightmer was then transported to Police Headquarters for processing. He was photographed and fingerprinted. It should be noted that Rightmer could not provide photo identification. His Interstate Identification Index shows him to have an Upon scanning Rightmer's fingerprints into they yielded the same FBI number. He was positively identified using said FBI number.

Rightmer was consequently charged with CGS: 14-12a*; Operating an Unregistered Motor Vehicle, CGS: 14-213b; Operating a Motor Vehicle without Insurance & CGS: 14-36(a); Operating a Motor Vehicle without a License. Rightmer was also processed for the warrant (see case #17-01983). He was placed in male holding cell #3 and is scheduled to be arraigned at GA:09 on January 27, 2017 at 0900 hours.

Rightmer was consequently charged with CGS: 51-164r(a); Failure to Respond to an Infraction. He is being held on \$92.00 court set bond and was placed in male holding cell #3. Rightmer is scheduled to be

arraigned at GA:09 on January 27, 2017 at 0900 hours. He was also processed for motor vehicle violations (see case #17-01982).

The warrant was cancelled out of the judicial system.
