Cheryl pulled out an XL UConn hooded sweatshirt from inside her right arm sleeve, valued at \$56.25. She also produced an XL Under Armour compression shirt from the small of her back, valued at \$34.99. When asked again if she had anything else, she replied, yes. Under her long winter coat, Cheryl was wearing an Adidas men hooded sweatshirt, valued at, \$41.25 and a UConn hooded sweatshirt shirt, valued at, \$33.75. All of the clothing had Bob's Stores tags attached. Total theft of, \$ 166.24.

who works at Bob's said that she followed Cheryl because she was acting suspiciously. said that Cheryl went into the fitting room and when she exited, she noticed a piece of clothing protruding from Cheryl's right arm sleeve.

Cheryl was issued an MSC for larceny 6th degree, 53a-125b and assigned a court date of 01/17/17 to appear at GA9 at 09:00 hours.

REMARKS

On 1/6/17 at approximately 02:59 hours I, Officer L. Woolard was dispatched to the area of Goodyear Avenue and Hotchkiss Street for a suspicious person complaint. Dispatch Services advised a local newspaper delivery man observed a black male wearing boots, black pants, and a hooded jacket walking in the area pulling on vehicle door handles. The caller said he last saw the black male walking towards the parking lot of 111 Church Street, Waters Edge Center for Health and Rehabilitation. Officer D'Aresta and Officer Bak were the assisting Officers.

Upon arrival to the Waters Edge I observed a black male matching the description provided by Dispatch Services. The black male was standing in between two vehicles parked in the parking lot. I then made contact with the black male who identified himself as Troy Hunter. Hunter did not have any form of picture identification on his person. Officer Bak who is familiar with Hunter and who has previously identified him through his photo ID confirmed his identity.

Hunter was on the property of Waters Edge Center for Health and Rehabilitation which is private property and which has posted signs prohibiting trespassers. Hunter was checking the door handles of all the vehicles in the parking lot to see if they were unlocked. Hunter entered an unlocked vehicle and took loose change amounting \$2.43. Hunter also took a AAA card and two Dunkin Donuts award cards.

Hunter was taken into full custody for violating C.G.S. 53a-109: Criminal Trespass in the Third Degree, and 53a-125b: Larceny in the Sixth Degree. Hunter was transported to Headquarters for processing and held on a \$5000.00 surety bond and given a court date of 1/6/17 at GA-9.


