REMARKS

On 10/24/2016 at approximately 18:53 hours I, Officer Austin Smith was dispatched to a home on Rising Trial Court for a physical domestic. The caller stated to emergency dispatchers that her father and her husband were in a physical fight and that her father now had her husband pinned to the ground.

Upon arrival I located the two males outside the front door of the apartment. The victim was identified as the caller's husband. The victim had blood on the right side of his head and right arm coming from cuts to his right ear, and right elbow. The victim also had scratches all over his arms and red spots on his forehead near his hairline.

The other man was identified as Robert Mosebach (Mosebach only had minor injuries to the knuckles on his hands.

The victim stated that he and his wife have been having some problems since moving in with his in-laws about a week ago and that he decided that he was leaving tonight. He told his wife that he had enough and that he was taking his 18 month old daughter with him. He stated that as he attempted to leave, his daughter was taken from him and he was attacked.


Mosebach stated that he intervened when the victim attempted to remove his granddaughter from the house. He stated that he had to restrain the victim to keep him from leaving with the child.

After interviewing the caller, the victim and Mosebach it was determined that the child was not present outside for any of the physical violence. The victim's injuries were consistent with his account of the incident. It was obvious based on Mosebach's lack of injuries to anywhere but his knuckles that he was the primary aggressor.

Robert Mosebach was issued misdemeanor summons #MC379688 for violating CGS 53a-61 Assault 3rd and 53a-182 Disorderly Conduct. Conditions of release were set and Mosebach was released on a promise to appear. Mosebach was scheduled to appear at GA09 Middletown on 10/25/2016.
