REMARKS

On Modnay, January 4th, 2020 at approximately 21:41hrs Middletown Dispatch received an open line 9-1-1 call. During the call they could hear a female yelling, telling someone to leave and that the call taker believed they had heard a knife being mentioned. Middletown dispatch looked up the phone number calling, which

showed a recent history of an address within this Officers district.

I, Ofc. Zadjura was assigned to investigate the incident and arrived on-scene a short time later with Ofc. Nettis. Upon our arrival we located two females standing outside in the parking lot within the vicinity of the reported address. These two females were identified as Victim 1 and 1. Both individuals informed officers on-scene they had called 9-1-1.

While en-route dispatch notified officers that a Jared Wilder () was the respondent of a Protective Order with Victim 1 as the protectee. The conditions of this order are as follows; CT01 - Do not assault, threaten, abuse, harass, follow, interfere with, or stalk the protected person. CT03 - Stay away from the home of the protected person and wherever the protected person shall reside, CT14 - Respondent may return to the protected person home one time to retrieve belongings, and CTF - Surrender or transfer all firearms and ammunition.

Victim 1 informed myself and Ofc. Nettis that Jared Wilder (DOB) had attempted to force her in to a back room by pulling on her arm and pushing her. She told him no and to stop several times. He became angry and grabbed her by the neck and choked her, forcing her on to the couch. She was able to escape after punching Jared in the face above his eye. He then went and grabbed a knife from the kitchen and threatened to kill her and her friend with a knife. Before she left the apartment she witnessed Jared cut himself and then blame her for the laceration to his hand. She then said Jared had come outside briefly before returning to the apartment.

Using an apartment key provided to us by Victim 1, Ofc. Bloom unlocked the door and made announcements to who ever may be inside at which point a male party emerged into view of the doorway with his hands up carrying a cell phone. This individual was identified as Jared Wilder . Jared denied Victim 1 and recollection of events, but would not provide officers with any additional information.

Both Victim 1 and provided written sworn statements pertaining to their recollection of the events.

Jared was placed under arrest and was processed for the violations of CGS 53a-223 - Violation of a Protective Order, 53a-61 - Assault in the Third Degree, 53a-62 - Threatening in the Second Degree and 53a-182 - Disorderly Conduct. He is currently being held in lieu of a \$75,000 bond. He is expected to be transported to GA09 (1 Court St Middletown, CT) on Tuesday, January 5th for arraignment.
