REMARKS

On 01/08/2021 at approximately 0354 hours, Officers A. Smith, Tavares, and I Officer Colon were dispatched to an undisclosed location for an initial report of an active domestic. Sgt. Petruilis arrived on scene shortly after.

We were let into the building by a neighbor who stated they heard yelling from apartment #7. Neighbors made me aware of the fact that there have been several physical domestic incidents reported for this unit.

We knocked on the door several times and identified ourselves at Middletown Police Officers. Kirk Dozier came to the door and identified himself as such. Dozier admitted that he and his girlfriend Victim 1 got into an argument, but denied getting into a physical altercation. I did not see any marks or bruising on Dozier that would lead me to me to believe otherwise. Victim 1 affirmed Dozier's statement and assured us that no physical domestic occurred. No marks or bruising were observed on Arrington.

While on scene Middletown Central Communications advised us that a no contact protective order was in place against Dozier, which listed Victim 1 as the protected person. The condition is as follows:

Do not assault, threaten abuse, harass, follow, interfere with, or stalk the protected person. (CT01)

Stay away from the home of the protected person and wherever the protected person shall reside.
(CT03)

Do not contact the protected person in any manner, including by written, electronic or telephone contact,
and do not contact the protected person's home, workplace or others with whom the contact would
be likely to cause annoyance or alarm to the protected person. (CT05)

Do not use or possess a dangerous weapon,

Do not use or possess an intoxicant or controlled substance. (alcohol or drugs)

At this time, Dozier was placed under arrest and placed in handcuffs. The handcuffs were double locked
and checked for proper fit. Dozier was escorted to Middletown Police Headquarters for processing. It
should be noted that Dozier was cooperative during our entire interaction.

Dozier was charged with violating CGS 53a-223* Violation of a Protective Order. Dozier was processed
and held on a \$15,000 surety bond, and is scheduled to appear at GA-9 on 01/08/2021.

A records checked revealed that Dozier has one prior conviction for violating CGS 53a-223*.
