

REMARKS

On Saturday, 01/09/21 at approximately 1821 hours I, Officer Jeffries, responded to the area of 286 East Main Street for a motor vehicle that crashed into a house.

Upon arrival, I observed a color black, 2006 Jeep Grand Cherokee bearing CT registration parked in the parking lot of 302 East Main Street (Irving Gas Station). The vehicle had moderate front end damage with concrete debris all over the hood of the vehicle.

It was later determined the above vehicle crashed into a house located at 286 East Main Street before backing away from the house and parking at the gas station listed above.

I observed a male lying on the ground. He stated his name was Benjamin Brower (driver/owner of vehicle). I was concerned for his wellbeing because he appeared to be slurring his speech and also appeared to

have facial droop. It was unclear if Brower was having a stroke, an unknown medical condition, or was under the influence of drugs/alcohol. Brower initially could not communicate to me what occurred during this incident because his speech was incomprehensible.

After an inquiry with Middletown Dispatch, it was determined the said vehicle had a suspended registration due to insurance. The said vehicle was towed by Alpha Auto.

Upon arrival at Middlesex Hospital ER, I spoke with Brower. He stated he was unsure what happened and denied drug or alcohol use.

Brower was arrested and issued a Misdemeanor Summons (MC 807882) for violation of C.G.S. 14-236, Failure to Drive in Proper Lane, 14-215(a), Operating a MV with Suspended Registration.

He was released on a Promise to Appear (PTA) and is scheduled to appear at Middletown Superior Court (GA-09) on 04/28/21.

REMARKS

On 1/14/2021 at 1829 hours, Middletown Police responded to the area of Farm Hill Road and Russell Street on the report of a physical altercation, possibly a domestic dispute occurring in the roadway between a black male and a black female. Middletown Police Dispatch advised that the male was wearing a black hooded sweatshirt while the female was wearing white pants.

Middletown Police Dispatch took a second 911 call from the resident of 306 Russell Street who stated the black male on her front steps was injured / bleeding and stating he had been attacked by the female.

Upon arrival, I pulled onto Russell Street from Farm Hill Road and observed an unoccupied Acura TL, bearing Connecticut registration marker plate stopped in the westbound travel lane. This was later determined to be Garth's vehicle.

A short distance east, I observed the black female wearing white pants, later identified as Chelsea Garth, standing on the curb line in westbound travel lane of Russell Street directly in front of residence 306. Residence 306 is about 300 feet east of the Farm Hill Road intersection.

I made contact with Garth and asked her if she was involved in a fight. Garth stated she was involved in a fight with her boyfriend, Male Victim #1, because she caught him cheating on her. Garth stated that she had struck Male Victim #1, but she also stated that he had choked her. Garth stated she was uninjured from the fight. Garth

immediately tried to cover it with his foot. The male was then later identified by his ID card as Salvatore Graham. Based on my training and experience as a police officer that Graham could potentially have more small waxed bags containing narcotics, search of his person was conducted. The search later revealed that Graham had a Newport cigarette box on him with two crack pipes with burnt residue in them and short cut straw. He was then placed under arrest and transported to Middletown Police department for processing.

While in the booking room, I had Graham take off his outer layer clothes and his socks. When Graham took off his right sock, three small wax-type white baggies fell out of his sock. I picked up the three baggies which were packaged the same way as the first one. However, with these three baggies, I observed them to contain a small amount of a white powder-like substance.

Using the necessary PPE and precautions, I tested the powder in one of the white bags utilizing NARK Heroin Test #NAR10003. The test kit immediately turned light green indicating the positive test for heroin. The total weight in its sealed container weighed 3.2 grams.

Graham is being charged with violating CGS 21a-267 Possession of Drug Paraphernalia and 21a-279 Illegal Possession of Controlled Substance. Graham was released on a \$5,000 non-surety bond and has a scheduled court date at GA9 on 04/12/2021 at 0900 hours.
