## REMARKS

On January 17, 2021, at approximately 1855 hours, I was dispatched to the area of Laurel Grove Rd. and Randolph Rd. for a single car motor vehicle accident into a tree.

While on scene I observed a dark colored pick up truck unrelated to the accident, bearing CT Reg driving northbound in the middle of the road. Sgt. White was on scene and told the operator to pull over to the side of the road. I observed the vehicle pull over to the western shoulder of the road and begin to drive over the embankment which leads to a steep drop on the western side of Laurel Grove Rd.

I observed a white male exit the drivers side door and later identified him a Nicholas Koba (25). While speaking to Koba I observed his eyes were glossy and blood shot and he appeared unsteady on his feet. Sgt. White and I both tried to explain where Koba parked was extremely dangerous but he became argumentative with us and would speak over us.

I asked Koba if he had consumed any alcoholic beverages prior to operating the vehicle. He told me he did and that he had consumed approximately 4 beers. I informed him I was concerned he had been operating his vehicle under the influence of alcohol and asked if he would consent to a series of Standardized Field Sobriety Tests (SFST's) to determine it. He stated he would do the SFST's. Koba did not perform these tests to standard. Central Dispatch also advised me Koba had a suspended license. He was placed under arrest and transported to Middletown Police Headquarters for processing.

Koba's first breath test, taken on the Draeger Alcotest 9510, was at 2008 hours (01/17/2021) with a result of .2375. The second test was at 2033 hours (01/17/2021) with a result of .2484.

As a result of this incident, Koba was charged with violating CGS 14-227a, Operating a Motor Vehicle Under the Influence of Alcohol/Drugs, and 14-215, Operating a Motor Vehicle with a Suspended License. Around 2115 hours he was released to his friends father, Keith Rushford, on a \$500 Non- Surety Bond and issued a court date of April 20, 2021 at GA9 for 0900 hours.

## REMARKS

On January, 15, 2021, at approximately 1631 hours, I was dispatched to 169 College St. on a Suspicious Activity complaint.

The reporting party, [redacted] informed Central Dispatch that Teresa Craft (69) was operating a vehicle, bearing CT Reg [redacted] and had attempted to run him over as he was on foot. [redacted] reported that Craft had left the area and was traveling on College St. (a one way road that runs west to east). Prior to my arrival on scene Officer Ward had conducted an investigatory motor vehicle stop on CT Reg [redacted] which was operated by Teresa Craft. The location of the motor vehicle stop was in front of Stella D'oro, 109 College St. See Officer Ward's supplement for further on Craft's operation of the vehicle.

I asked Craft if she would consent to a series of Standardized Field Sobriety Tests (SFST's), which she initially agreed to. She did not perform the HGN to standard, and was unable to perform the two other standardized tests. She was placed under arrest and transported to Middletown Police Headquarters for processing.

Craft's first breath test, taken on the Draeger Alcotest 9510, was at 1731 hours (01/15/2021) with a result of .1060. The second test was at 1752 hours (01/15/2021) with a result of .0970.

As a result of this incident, Craft was charged with violating CGS 14-227a, Operating a Motor Vehicle Under the Influence of Alcohol/Drugs. She was released to a family member on a \$500 Non-Surety Bond and issued a court date of April 19, 2021 at GA9 for 0900 hours.
