On January 22, 2021 I, Officer Wade, was assigned to evening shift patrol.


On this date I was dispatched to a minor motor vehicle accident involving three vehicles on Washington St. The driver of one of the vehicles involved (CT Reg. - silver Lexus RX300) was identified by ID card as Nicole Marie Bell, An inquiry was conducted with Middletown Central Communications and it was discovered Bells' drivers license was currently under suspension. Upon officers' arrival, another party on scene stated they were driving the Lexus and not Bell. Officers spoke with another party on scene who stated Bell was the person driving and prior to police arrival, told the party he better not say she (Bell) was driving because her license was suspended. After being informed there was video footage, as well as a witness who stated Bell was driving, Bell admitted she was actually driving and was the only one in the vehicle.

Bell was issued a Misdemeanor Summons (MC 397946) for Operating Under Suspended License - violation of C.G.S 14-215. Bell is scheduled to appear in GA 9 court on April 20, 2021 at 0900hrs. Nothing further.

REMARKS

On 01-25-2021 at approximately 1310 hours I, Officer Thompson, was dispatched to 100 Randolph Rd. (Middlesex health care) for an assault.

Upon arrival I spoke with the nursing supervisor who stated a patient assaulted another patient for no reason. I then spoke with the victim who stated he was struck in the back of the head by Herman Bartell. The incident began after the victim refused to shake Bartell's hand. The victim was sitting in a wheel chair and Bartell struck him in the head roughly four times. Bartell also ripped out of a piece of the victim's hair. The victim stated he had a pounding headache from the altercation. He provided a sworn written statement and requested Bartell be arrested for assault.

I then spoke with a witness who provides physical therapy at Middlesex health care. She heard commotion going on and an aide yelling for help. She observed the victim in a wheel chair and Bartell was attacking

him from behind. She saw Bartell punch the victim and he had both of his hands gripped onto the victims hair. She said Bartell had "a look of intent to harm" and it appeared he was assaulting the victim. The witness provided a sworn written statement of the incident.

I made contact with Bartell who was in the crisis unit at Middlesex hospital. I questioned him about the incident and asked why he struck the victim. Bartell stated "he was talking shit". He did not elaborate on what was said and did not give me further details.

Bartell was issued Misdemeanor Summons and Complaint # MC 807556 for the following violation of CT general statute.

53a-61 - Assault 3rd degree

I was able to identify Bartell though prior police interactions and he was issued a court date of 05-19-2021 at GA 9.






