On 02/05/2021, at approximately 0135 hours, I responded to a residence in Middletown for a report of a domestic disturbance.

While en route, Victim # 1 reported that his brother, Noah Cedeno, was refusing to leave. Victim # 1 stated that the altercation between them became physical and his brother ultimately left the scene in his vehicle.

Upon my arrival, I made contact with Victim # 1 and Cedeno's girlfriend, They reported that they were consuming alcohol earlier in the night and Cedeno left the residence after waking up at around 1130 PM. Victim # 1 stated that at around 130 AM Cedeno returned and was banging on the door and wanted to come inside. Cedeno wanted to get a key to his girlfriend's house in Meriden. did not want Cedeno to have the key since only her mother was currently at the house. Cedeno became agitated and started screaming and yelling at Victim # 1 to let him inside. While at the threshold of the front door, Cedeno tried to push past Victim # 1 and Victim # 1 held him back. At around this time Victim # 1 called police for help. Cedeno continued to argue and ultimately began swinging punches at Victim # 1. Victim # 1 reported that Cedeno was hitting him in the face and would not stop. Victim # 1 stated that in self defense he grabbed onto Cedeno, brought him to the ground and pinned him down. Cedeno was able to get free, got into his truck and left the area. During this physical altercation Victim # 1's dog got free and bit Cedeno several times in his arms.

Victim # 1 had a small laceration on his right elbow and redness around his left eye from being punched.

Officers made contact with Cedeno over the phone and requested him to respond to this department.

At approximately 0300 hours, Cedeno arrived at this department. Cedeno reported that he currently has an issue with drinking too much alcohol and had too much to drink at Victim # 1's house. Cedeno stated that he had left Victim # 1's house earlier in the night and returned at around 0130 AM. When he returned he was trying to get inside and get a key to get into his girlfriend's house. He reported that his brother did not want him inside, refused to let him in and refused to get him the key. Cedeno stated that he got upset and admitted to arguing, fighting and punching his brother, Victim # 1. Cedeno stated that during the altercation, Victim # 1 was able to throw him to the ground and hold him down. Cedeno stated that he got free, left and drove to his mother's house. Cedeno stated that while he was fighting Victim # 1, Victim # 1's dog ran over and started to bite him in his arms. Cedeno had several small puncture wounds on his arms.

Cedeno was advised that he was being placed under arrest and charged with Assault in the Third Degree 53a-61 and Disorderly Conduct 53-182. Cedeno was issued Misdemeanor Summons # MC808471 and released on a \$5,000 non-surety bond. Cedeno is scheduled to appear before GA-9 on 02/08/2021, at 0900 hours.
