_____ stated a short time later Earley came across the street to Main and liberty and again began to accuse her of stealing. _____ stated Early, then punched her in the nose for no reason and without provocation. _____ did sustain a minor abrasion to the bridge of her nose as a result of the assault. _____ explained that her nose was also in pain. _____ then stated she did wish to have Earley arrested for assaulting her.

At this time this officer spoke with _____ who reiterated exactly what _____ had stated. _____ did not wish to give this officer a written statement but agreed to a verbal statement of the events.

When Officer DiFonzo first met with Earley on scene she denied that she was involved in the incident. However after a few moments she admitted to the altercation. Due to the facts and circumstances mentioned above Earley was placed under arrest and transported to the Middletown P.D.
