### Charges

1: 53a-223\* (VIOLATION OF PROTECTIVE ORDER )

On 2/19/21 at approximately at 0107 hours, Ofc Delima and I (Ofc. Thomas), were dispatched to 62 Murray St. for Rocky Hill Police Department on a wellbeing check. The complainant, a former employee of the victim 1, reported that while she was speaking to victim 1 on the phone, she heard Philip yelling at her to "get off the phone" The entire incident happened about 45 mins to 1 hour ago. Both victim 1 and Philip confirmed what happened. Victim 1 stated that Philip did not hit her in any way at the conclusion of the investigation.

I knocked and made contact with a white male Philip . I asked if victim 1 was ok. Philip responded "yes" I asked Philip's dad if he could get victim 1 to come upstairs and talk with officer's. Ofc. Dilema remained in the living room area with Philip to get his verbal statement on what happened earlier. I took victim 1 into the kitchen area to further investigate the incident. Both series of events matched according to both parties which was, victim 1 was afraid to go into work because of inclement weather(snow). Furthermore, victim 1 was attempting to call out of work when her boss allegedly asked her to find coverage for calling out. Philip became upset to the fact that victim 1 was responsible to find coverage and shouted to "hang up the phone."

Both parties were ran through dispatch. Dispatch notified officer's that an active Full Protective order was in place: Do not assault, threaten abuse, harass, follow,interfere with,or stalk the protected person. Stay away from the home of the protected person an wherever the protected person shall reside. Do not contact the protected person's in any manner. Do not use or possess a dangerous weapon. Do not use or possess alcohol or drugs. The Protected was victim 1 and the Respondant is Philip. Both parties are intimate cohabitants where Philip now lives and victim 1 resides in Haddam CT.
