On 2/22/21 Officer Colon and I (Officer Wasilewski) were dispatched to a residence in Middletown for a possible domestic disturbance. The caller reported that they could hear a male possibly physically assaulting a second male. The caller also reported that they had an audio recording on their phone of what sounded like a physical altercation which they would provide to Officers. This officer is aware that the two accused males live together on the 1st floor and have responded to the address for several verbal arguments.

Upon my arrival I knocked on the south side door by the driveway. After knocking several times I knocked louder and identified myself as the "Middletown Police Department" "Open the door". After knocking for several minutes the older male, Hereby referred to as Victim 1 or V1, answered the door. His face was wrapped in a thick black color fleece ski mask with only his eyes showing. Even with the little amount of his face and eyes showing through the mask, I could see that he had a fresh cut above his left eye and his right eye was very swollen. I then asked him to step inside and informed him that I needed to speak with him and the other male in the apartment (Patrick Hayes). I explained to him that he received another complaint that they had been fighting. Both denied the claim and stated nothing happened. This Officer was able to positively identify both V1 and Patrick through several previous law enforcement interactions.

I then asked V1 to remove his winter mask which he then did. I then saw that his face had several fresh noticeable injuries. His shirt also had fresh blood stains by the collar. Partially dried blood was below his nose on his upper lip and fresh blood was on his left eye and right cheek. While speaking to both I noticed fresh wet blood droplets on the living room floor by a weight bench and dumbbell weights. I pointed out the blood and asked what that was from. V1 told this Officer it was "ketchup". Patrick said "No, no it just from

ARRAIGNMENT REPORT AND AFFIDAVIT

Warrantless Arrest

V1. He fell down again". V1 then stated "Oh yea, I'm really clumsy". When asked if he wanted medical attention V1 stated he was not going to the hospital and claimed Officers were harassing him.

This Officer then spoke with the complainant who had an audio recording of what she heard. The audio started with Patrick yelling at V1 that he was a "Stupid Faggot!" "Your not my boy!" "Clean that shit up right now!" A slap type noise, which could have been a punch or slap, is heard immediately followed by V1 yelling "OUCH!!! STOP IT!!!" Patrick is then heard yelling very loudly "Clean that fucking floor! You pissed on the floor where you live! What the fuck is wrong with you!" It was clear from that audio that a physical altercation had occurred and V1 appeared to be the victim judging by Patrick's aggressive tone and V1's more meek submissive tone in addition to him yelling in pain after what sounded like him being struck in some manner.

Due to the physical evidence, the verbal statement provided to this Officer from the complainant, and the audio recording which this Officer listened to, Patrick was placed under arrest for Assault. V1 refused to provide a statement and became verbally aggressive toward Officers when Patrick was told he was under arrest.

Patrick Hayes was then transported to the Middletown Police Department where he was read his rights, photographed, and fingerprinted. He was charged with violation of CGS 53a-182 Disorderly Conduct and 53a-61a Assault 3rd Degree. Patrick was held on a \$10,000 Surety Bond and scheduled to appear at the GA 9 Court house on 2/23/21 at 0900hrs.
