On 2/28/21 at 1400 hours, I, Officer Carta, was dispatched to an undisclosed address for a domestic disturbance. Dispatch stated that the caller's mother's boyfriend, Kyle Wetherington, put his hands on the victim. Officer Santostefano responded as well.

Upon arrival, I made contact with Wetherington behind the residence. I asked Wetherington what happened, and he stated that he got into a verbal argument with the victim and threw her cell phone against a wall. Officer Santostefano stood by with Wetherington, while I made contact with the victim.

The victim stated that her and Wetherington have been in a dating relationship for 10 months and have been having relationship issues. The victim stated that when they began talking about their relationship issues today, Wetherington became frustrated and took her iPhone out of her hands and threw it against the bedroom wall. The victim stated that her phone did not sustain any damage. I observed the iPhone and observed no visible damage.

Wetherington was issued Misdemeanor Summons and Complaint (MC 808442) in violation of C.G.S. 53a-182 Disorderly Conduct. Wetherington was released on a Promise To Appear and must appear to Middletown Superior Court GA 9 on 3/1/21 at 0900 hours.

On 2/28/2021 officers responded to VICTIM ADDRESS for a report of a possible domestic disturbance.

Dana Sweeney was placed under arrest for multiple active warrants and also later domestic related charges. He was transported to Middletown PD headquarters.

Officers spoke on scene with VICTIM who was crying hysterically, asking where her phone and watch were. I was informed by officers at headquarters that Sweeney stated he threw VICTIM phone in the woods. I obtained a sworn written statement from VICTIM in regards to the incident. VICTIM stated she and Sweeney got into a verbal argument earlier in the day and after leaving and returning to the home, Sweeney began banging on her front door. VICTIM opened the door and Sweeney began yelling, calling her a liar, and stated "if you lie to me again I'm gonna break your face." Sweeney also stated he would "go to jail for the rest of his life to prove a point." VICTIM stated Dana then ripped her ear buds out of her ear, grabbed her phone and threatened to smash it into pieces. VICTIM stated Sweeney put her on the bed and held her down by her neck using his hand, causing pressure and some pain. VICTIM was crying and Sweeney threatened to punch her in her face if she continued. Sweeney took her watch and stated "don't you dare come out of the room or it will be bad for you." VICTIM heard the police knocking on the door and eventually was able to come downstairs and open it. VICTIM stated that throughout this entire incident their five (5) year old son was in the kitchen and able to hear the incident.

Dana Sweeney was charged with 53-21 Risk of Injury, 53a-117 Criminal Mischief, 53a-182 Disorderly
