On March 18 2021, Victim 1 arrived at police headquarters to make a threatening complaint.

I spoke to Victim 1, who stated that her ex-boyfriend of 18 years, Patrick Munson who she has two children in common with, drove over to her sister's residence, where he knows she is residing. Victim 1 stated that P Munson beeped his car horn for approximately 15 seconds straight at approximately 0600 hours on a dead end residential neighborhood. Victim 1 stated she walked outside to greet her daughter, who P Munson dropped off. Victim 1 stated that P Munson screamed, "I'm gonna fucking kill you and smash your teeth in". P Munson then immediately burned out in the cul de sac with his vehicle at a high rate of speed, screeching his tires leaving a rubber tire mark on the pavement.

Sgt B White, Ofc Nettis and I responded to 30 Highland Terrace, in attempts to arrest P Munson. When speaking to P Munson, he stated, "I am not getting arrested and will be calling my lawyer, get off my property!" P Munson began walking away and resisted arrest. P Munson fought with officers and would not allow them to handcuff him. Eventually, P Munson was handcuffed and taken into custody.

Ofc Scrivo booked and processed P Munson, who was identified by CT License number , was arrested for violation of the following statutes

- 53a-62 Threatening in the Second Degree
- 53a-181 Breach of Peace in the Second Degree
- 53a-167a Interfering/Resisting
